### **Key Responsibilities and Duties**

Project Ignite will see the replacement of Resthaven's core systems, the Integration Developer will work closely with the Ignite team as well as the ICT team during the life of this project.

The Integration Developer will undertake duties in accordance with the philosophy, business practices and policies of Resthaven Incorporated, and perform the following duties:

- Working closely with vendors, project and applications teams to define and develop point to point application links to support cross-functional applications bidirectionally.
- Work closely with the project team to define integration requirements
- Develop and build integration connections both point to point and with a middleware platform, across laaS, PaaS and SaaS environments.
- Ensure the integration requirements of each system are met and align with each other by liaising with the software vendors, project team members, internal business units, and IT.
- Develop a plan for testing integration prior to live deployment
- Work closely with the project team and vendors to establish a middleware platform
- Define and develop application integration with the middleware platform
- Administer the integration functions of each separate software system, monitor integration audit logs, determine cause of failures, and re-process transactions after data issues resolved
- Carry out integration support, making initial diagnosis of problems, for a system or subsystem
  or apply known solutions, including documenting problems, progress checking, and escalating
  to ensure resolution.
- Document all interface and integration connections and compile all supporting material to enhance ongoing support
- Implement interface monitoring and develop an improvement lifecycle structure
- Travel to other Resthaven facilities as required to undertake role responsibilities
